STATUTES GOVERNING AFFILIATION TO RESEARCH CENTRES -2012
(Statutes formed under section 47 of Karnataka Samskrit University Act 2010)

The University shall recognise any Registered Institutions on its application to recognise as Research Centre of the University with the following conditions. In such Institutions any eligible candidate may get admission for conduct of research leading to Ph.D. Degree and any other courses of the University.

1. Such Institution established by the Central Govt./State Govt./any Autonomous body of State and National reputation, shall provide the facilities to study and conduct research. If the Institution is established by a private trust, it should successfully complete atleast five years in its field of research with substantial publications before applying for Research Centre.
2. The Vice-Chancellor, in consultation with the Dean of the concerned subject shall constitute an Inspection Committee comprising of five members of which three members shall be external experts, one member shall be the dean of the University and the other member shall be from the Academic Council. The Vice-Chancellor shall nominate one person as Chairman amongst the members. The members of Inspection Committee shall document the details of Research Centre parawise. The Syndicate and Academic Council shall examine the recommendations of the Inspection Committee and advice suitable action for granting permission or otherwise to Research Centres. The Director of Research Wing will take necessary action.
3. The Research Centre shall provide accurate information regarding its contribution to the Samskrit or classical treatises (Shastras) taught in its Centre.
4. The Institution shall pay the fees through Demand Draft prescribed by the University along with the application form. The Syndicate shall prescribe specific fees from time to time before granting permission and before or after the inspection.
5. The Samskrit University may grant affiliation to those Research Centres which have eligible research supervisors, good library and infrastructure.
6. The scholars/researchers qualified as per UGC norms working in such recognised Institutions are eligible to guide the research students for Ph.D. Programme. However they are required to submit application alongwith guide recognition fee to the University for getting recognition as research supervisor of the University.

7. Such recognised Institutions must invite the representatives of the University nominated by the Vice-Chancellor to its meetings of academic and administrative bodies.
8. Such recognised Institutions may conduct classes for certificate and diploma courses with the permission of the University.
9. A notice has to be served for the Head of such Research Centres before either modifying or cancelling the recognition and seek explanations from Research Centres in that regard. The Vice-Chancellor having sought the permission of the Syndicate shall take suitable action with respect to the recognition or otherwise of that Research Centre. The Syndicate of the University reserves the right to either modify or cancel the recognition given to Research Centres.
10. If any Research Centre having submitted for recognition is desirous of withdrawing fifteen days earlier to the date of inspection, then only 50% of the registration fees shall be returned. The Research Centres can not claim fee paid, if the Centre withdraw its application after inspection.
11. No Institution shall have recognition from Two Universities at a time. According to the section 47 of Karnataka Samskrit University Act 2009, the Research Institutes are eligible to get the recognition as Research/Study centre. However, they shall not be considered as affiliated to the University.
12. The Vice-Chancellor shall possess the power to solve disputes if any. The decision of the Vice-Chancellor shall be final.

Fees prescribed for the next three year:

1. Inspection Fee: Rs. 2000/- and TA as per University rules will be borne by the Research Centre
2. Registration Fee: Rs. 10,000/- (Rupees Ten thousand only)
3. Triennial Affiliation Fee: Rs. 5,000/- (Rupees Five thousand only)
