Candidates having Qualifications and Experience in the concerned subject may apply for the post. **Separate application form is required for those who are applying for more than one post.**

Qualification required for the Post of Professor in Subjects other than Manuscriptology as per the UGC Guidelines and University C&R rule.

- 1) An eminent scholar with Ph.D (through course work) qualification in the concerned/ allied/relevant discipline and published work of high quality, actively engaged in research with evidence of published works with a minimum of 10 publications as books and / or research /policy papers in indexed / ISBN /ISSN numbered journals and/or ISBN / ISSN numbered books and the University developed ISBN / ISSN numbered list of journals/books hosted in the website of the concerned University.

- 2) Must have acquired specialized expertise in the traditional system in the respective area and a Vidwath degree with distinction. Contributed to the achievement of an outstanding and talented work in the concerned field. Publication of atleast 10 Sanskrit research papers in journals.
- 3) A minimum of 10 years of teaching experience in University/college, and/or experience in research at the University/ National level institutions / industries, including experience of guiding candidates for research at doctoral level;
- 4) Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process.
- 5) A minimum score as stipulated in the Academic Performance Indicator (API) based on Performance Based Appraisal System (PBAS) developed by UGC in its Regulations.
- 6) Preference being given for having published Sanskrit research papers in journals.

OR

An outstanding professional with established reputation in the relevant field who has made significant contribution to knowledge.

Qualification required for the Post of Associate Professor in Subjects other than Manuscriptology as per the UGC Guidelines and University C&R rule.

- 1) 55% of the marks, or equivalent grade wherever grading system is followed at the Master's degree level in relevant Shastra/Subject.
- 2) Good academic record with Ph.D. degree through course work in the concerned/allied /relevant disciplines.
- 3) A minimum of 8 years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University/College or Accredited Research Institution/ industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers in indexed/ISBN/ ISSN numbered books/journals.
- 4) Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process with evidence of having guided doctoral candidates and research students.
- 5) A minimum score (75 in Cat I, 15 in Cat II and 300 in Cat III) as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS) developed by UGC in its Regulations.
- 6) Distinguished and eminent learning having acquired high repute for propagation and dissemination of the Sanskrit knowledge.

Qualification required for the Post of Assistant Professor in Subjects other than Manuscriptology as per the UGC Guidelines and University C&R rule.

- 1) Good academic record as defined by the concerned University with at least 55% of the marks or equivalent grade wherever grading system is practiced at the Master's degree level in a relevant Shastra/Subject from an Indian University or an equivalent degree from an accredited foreign University.
- 2) Besides fulfilling the above qualification, the candidate should have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar tests accredited by the UGC like SLET/SET.
- 3) Holders of Ph.D. degree as on the date of Notification of UGC Regulations, along with those candidates who are awarded a Ph.D. degree through a process of admission, registration, course work and external evaluation as laid down in the UGC (Minimum Standards and procedures for award of M.Phil./Ph.D. Regulations, 2009 and so adopted by the university, shall be exempted from NET/SLET/SET.
- 4) Distinguished and eminent learning having acquired high repute for propagation and disseminating of the Sanskrit knowledge.

Qualification required for the Posts in Manuscriptology subject as per the UGC Guidelines and University C&R rule.

ASSISTANT PROFESSOR

- (A) The minimum requirement of a good academic record, 55% marks (or an equivalent grade in a UGC Seven point scale wherever grading system is followed) at the master's level in Samskrit/or Equivalent in Tradition Samskrit subjects.

and

- (B) Specialized study of Manuscriptology at M.Phil. degree with a dissertation on critical edition on Samskrit Manuscripts and capacity to be demonstrate to decipher atleast two ancient scripts used to write Samskrit manuscripts

Or

Specialised study of Manuscriptology at PG Diploma in Manuscriptology of a University and capacity to be demonstrated to decipher atleast two ancient scripts used to write Samskrit Manuscripts at PG Diploma in Manuscriptology.

and

- (C) NET/SLET as applicable in Samskrit or in Tradition Samskrit subjects

Or

Specialised study of Manuscriptology at Ph.D. Degree in Samskrit with a Thesis on critical edition on Samskrit Manuscripts or Equivalent Ph.D. Degree in Tradition Samskrit subjects with a Thesis on critical edition on Samskrit Manuscripts as applicable under latest UGC regulation.

ASSOCIATE PROFESSOR

- (A) Good academic record with a Ph.D. Degree in Samskrit with a Thesis on critical edition on Samskrit Manuscripts or Equivalent Ph.D. Degree in Tradition Samskrit subjects with a Thesis on critical edition.
- (B) A specialised study of Manuscriptology and atleast two ancient scripts used to write manuscripts evidenced in the Thesis produced.
- (C) A Master's Degree in Samskrit or Equivalent in Tradition Samskrit subjects with 55% marks (or equivalent grade in a point scale wherever grading system is followed)
- (D) A minimum of Eight years of experience of teaching and/or research on critical edition on Samskrit Manuscripts in an academic/research position equivalent to that of Assistant Professor (with UGC Assistant Professor Pay Band and Grade pay) in a University, College or Accredited Research Institution/industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers on Manuscript studies.
- (E) Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process with evidence of having guided doctoral candidates and research students on Manuscript studies.
- (F) A minimum 300 points score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in Appendix III of latest UGC Regulations applicable.

PROFESSOR

- (A) An eminent scholar with Ph.D. qualifications in Samskrit or Equivalent Ph.D. Degree in Tradition Samskrit subjects
- (B) Published work of high quality on Manuscript studies, actively engaged in research- critical edition on Samskrit Manuscripts with evidence of published work with a minimum of 10 publications as books and/or research/policy papers on Manuscript studies.
- (C) A minimum of ten years of teaching experience in University/College, and/or experience in research at the University/National level Institutions/industries, including experience of guiding candidates for research at doctoral level on critical edition, deciphering ancient scripts and reading manuscripts.
- (D) Contribution to Manuscript related educational innovation, design of new curricula and courses, and technology-mediated teaching learning process.
- (E) A minimum 400 points score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in Appendix III of latest UGC Regulations applicable.

OR

An outstanding professional, with established reputation in the field of Samskrit Manuscript studies, who has made significant contributions to the knowledge in Manuscriptology/critical edition discipline, to be substantiated by credentials.

Qualification required for the Post of Librarian as per the UGC Guidelines and University C&R rule.

- 1) Master's degree in Library Science/Information Science with at least 55% of the marks or its equivalent grade for 55% where grading system is practiced.
- 2) A Ph.D. in the above discipline and/or allied discipline with a consistently good academic record.
- 3) A minimum of 15 years of teaching /librarian experience of which at least 5 years experience as Deputy Librarian in a University Library or 10 years experience as Assistant Librarian in the University or as College Librarian.
- 4) Evidence of innovative library service and organization of published work and ICT modernization of Library. Evidence of published work with a minimum of 10 books and/or publication in indexed/ISBN/ISSN numbered journals/books and University developed ISBN/ ISSN numbered list of journals posted on the website of the concerned university.
- 5) A minimum score 400 in Cat III as stipulated in the Academic Performance Indicator (API) based on Performance Based Appraisal System (PBAS) developed by UGC shall be mandatory requirement.
- 6) Distinguished and eminent learning having acquired high repute in Sanskrit. Should have acquired Vidwat with distinction in Traditional System in any field of specialization.

Qualification required for the Post of Assistant Librarian as per the UGC Guidelines and University C&R rule.

- 1) Master's degree in Library Science/Information Science/Documentation Science or an equivalent professional degree with atleast 55% of the marks or its equivalent grade for 55% marks where grading system is practiced and a consistently good academic record with knowledge on computerization of library.
- 2) Qualifying in the National Eligibility Test (NET) or other accredited test like SLET/SET in Library Science conducted for the purpose by the UGC or any other agency approved by the UGC.
- 3) Holders of Ph.D degree as on the date of notification of UGC Regulations, along with those candidates who are awarded a Ph.D degree through a process of admission, registration, course work and external evaluation as laid down in the UGC (Minimum Standards and procedures for award of M.Phil/Ph.D degree) Regulations, 2009 and so adopted by the University shall be exempted from NET/SLET/SET
- 4) A minimum score as stipulated in the Academic Performance Indicator (API) based on Performance Based Appraisal System (PBAS) developed by UGC shall be mandatory requirement.

Notes:

1. Qualification and other eligibility conditions are as per UGC Regulations 2010 published in the Official Gazette of India dated September 18, 2010 and the Statutes governing the Cadre and Recruitment of the Employees of Karnataka Samskrit University.
2. Reservation norms are followed as per the orders issued by the Government of Karnataka from time to time. Non-Karnataka candidates are not eligible to claim the reservation.
3. D.D. towards Total fees **Rs. 1000/- (Non-Refundable)** shall be drawn in favour of '**Finance Officer, Karnataka Samskrit University, Bengaluru**' payable at Bengaluru. (50% processing fee in case of SC/ST & Cat-I).
4. API Score will be awarded only on production of relevant documentary evidence in support of claims made duly signed by the competent authority.
5. University reserves the right to fill or not to fill any of the vacancies notified.
6. The University has right to shift any post from one faculty to another as per requirement.
7. Incomplete and Late Applications will not be considered.
